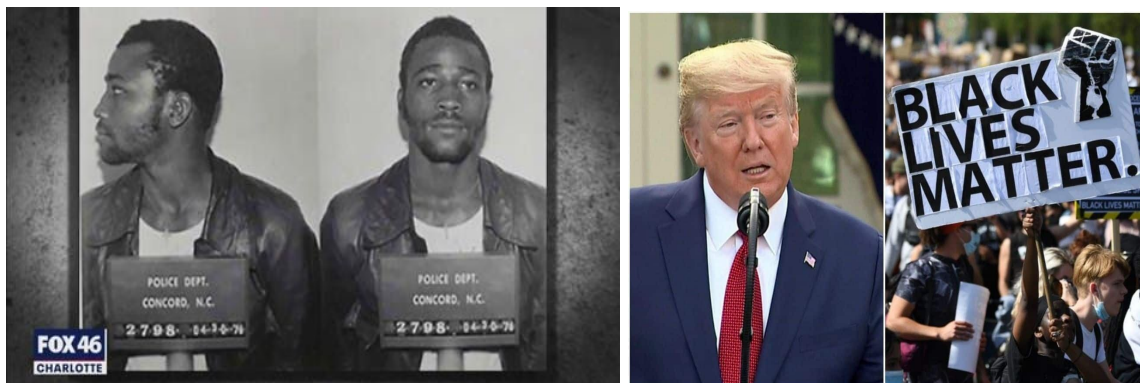

Tests and evidence was collected, such as the 43 fingerprints at the scene and “although there was no physical evidence tying Long to the crime, he was convicted by an all-white jury, and given an 80 year sentence(...) they took my life away from me when I was 20 years old,”. A piece of hair, a rape kit, fingerprints were all taken in as evidence, which did not match Ronnie Long. Why did Ronnie long get convicted of a crime he didn't do, sentenced for 80 years, spending 44 years of his life in jail? The full answer will remain unknown. Something that can be evaluated as true is that an innocent black man was prosecuted by an all-white jury, by a white woman, after all the evidence wasn't aligned to him. Racism can be compared to air , the second someone is born they breathe it in. It's taught and is a disease that spreads across the world. If Ronnie Long was a white man would he have been accused of a crime he didn't do? The fact that one even has to wonder the answer to this question proves that equality has been crushed and isn't an American value that is lived up to.
