**GOOD ADVICE RE LAWYERING-EXCEPT**

**Except, where did Mr. Trump find this guy Bruce Castor for a defense attorney who clearly established a category inferior to acting as one’s own lawyer? How disjointed and inarticulate this man was in his first day of presentations to the Senate jury in the Trump impeachment case.**

**The testimony and film footage provided by the impeachment managers was truly**

**gripping, with outstanding presentations by Jamie Raskin, Madeleine Dean and Stacey Plaskett. None of the other speeches or media coverage I have reviewed came close to giving the feeling of sheer terror that must have been felt by members of Congress and the Senate.**

**private citizen (Trump) held before the Senate would be nothing more or less than the trial of a private citizen by a legislative body. An impeachment trial by the Senate of a private citizen violates Article 1, Section 9 of the United States Constitution,”**

**Much is made by those saying this is a legitimate trial by referring to an impeachment trial in 1876 of the then recently resigned Secretary of War, William Belknap, as precedent for why today’s impeachment trial is justified.**

**Eugene Kontorovich is a constitutional law expert at George Mason University, He points out with regard to the Belknap trial that, “questions about the constitutionality (of the trial) helped lead the Senate to acquit him.”**

**So, instead of there having been a clear cut case in 1876, the Senate had the same problem then, as now. Mr. Kontorovich continues, “Congress did not even pursue the reviled Nixon when he entered private life, because it was understood he could no longer be impeached.”**

**The other lynch pin being used by those who contend this is a legal trial is to prevent any president from engaging in unlawful behavior at the end of his time in office. Those on the other side of this debate contend that is why we have the criminal code of justice.**

**Supporting that, in one of Mr. Castor's few cogent comments he said, "If Trump actually played a part in the Capitol riot, after he's out of office, you go and arrest him."**

**I think it's highly likely that once the trial is over and Trump is acquitted once again, that some members of Congress will request the Department of Justice to institute criminal proceedings against him.**

**To many, since the Democrats know they can't convict Mr. Trump, and therefore block him from any future Federal office, it appears the aim is to so tarnish his reputation that the public will long remember this time, having the same effect with regard to ending his political career.**
