All,

Over the past few weeks, someone has been destroying COVID-awareness signs, such as those posted to entrance doors, and trashing disposable masks and sanitizers placed in public areas. It seems these actions are being taken by someone who is regularly in the KSU Center during business hours, so it is probably a KSU employee. The troubles were taken to a (creative) new level over the past 24 hours. The signs that say "Please wear a mask" were replaced by signs of very similar design that say "Masks not required."

In any case, a CPE employee has filed a report with the KSU Police and sent a message to KSU HR and the Office of Emergency Management to make authorities aware of these acts. And I'm going to ask Chris Page to investigate the use of security cameras.

But it seems that an easier, and less dramatic, method to ending this is a reminder that destruction of signs and safety equipment is the destruction of university property. I hope the person(s) would rather cease these acts rather than risk getting caught and face the pertinent ramifications.
